I am in receipt of your letter dated May 22, 2009 indicating to me you have provided me a copy of the Independent Auditors Report issued by Rossmann MacDonald & Benetti, Inc ("RMB") applicable to the California Association of Licensed Investigators. Additionally you have not provided me any documents applicable to CALI PAC although it is funded by CALI.

As I previously stated to you, the two sheets of paper you provided to me could not be the complete Independent Auditors Report as issued by RMB. This documents fails to contain any professionally prepared Income and Expense Statement as well as any Notes to the Financial Statements. Additionally I certainly don't think that a CPA firm with the credentials you have outlined in your letter would be so negligent in issuing a Audit Report without important information such as the income and expenses and I don't believe that the Excel spreadsheets attached to the report listing income and expenses were part of any report issued by RMB. The manipulation of the Audit Report makes it appear to me that someone is trying to hide something.

In order for me to critically access the financial condition of the Association and dispel the rumors of fraud and financial mismanagement concerning the finances of CALI, I again request a complete copy of the financial report issued by RMB and access to the financial records of CALI as required by law.

Your prompt attention is expected since my initial request for information goes back to April 1, 2009.

If there is legal precedent you wish to cite to prohibit my access to the Association's records please inform me immediately. Please note that nothing in this notice should be construed as a waiver of any rights, remedies or

protections under law. If I do not receive an affirmative response indicating that the association is complying with my request I will be forced to take the full legal remedies available to rectify this situation.
